# **National TBF Meeting**

- Presidents meeting
- Changes were voted on
- Not unanimous
- In effect for next year

# National Concerns/Complaints

- Membership declining
- Hard to encourage new people, especially nonboaters
- Costs too much to travel
- Hard to get enough vacation time
- Not enough prize money to make it worth it
- Same people on the team every year
- Only competing against your own team
- 4 year process from club to national

## Goals in new national TBF strategy

- Increase membership
- More opportunity to go on
- More opportunities for co-anglers
- Less travel
- More Weekend Schedules
- Reduce Cost
- Better Prize money
- All in one year

# TBF Has Changed

- Business model has not changed in 20 years, no corporation would stay in business if they didn't ever change with the industry
- Last few years TBF was focused on improving youth which was highly successful, now focused on adult programs

### Make the Most of It

- Majority vote of State Presidents
- Some good, some downsides
- Still happening regardless
- Make the most out of it
- Does no good to complain, will only hurt our organization
- Focus on positive opportunity for change

# Changes to Divisionals

- States will no longer compete as teams- no combined weights, no combined payouts
- Smaller divisionals- 2-3 states per divisional= less travel costs
- Less time frame- weekend tournament
- Boater- Co-Angler Format, not competing against each other
- \$200 boater, \$100 co angler entry fee= more prize money

### Continued

- Held in the Fall (same qualifying year as state)
- States are not limited to 12 competitors
- States with more members send more people to divisionals
- Two methods to qualify for divisionals
  - 10% of participants in state qualifier(s)
  - 2 people from each club (if club meets our criteria)

# Changes to Nationals

- For every 50 participants at divisionals send another pair to nationals
- If more than 1 pair from our state, they have fish off before final days
- Higher payout- goal to get to \$1 million payout
- Double qualifier year in 2017

# **Tournament Committee Proposal**

- All clubs were invited to the meeting
- Thank you to all those who participated- they spent a lot of time discussing different options and put a lot of thought into what would be best for our future
- Extremely respectful group
- Starting point for a complicated topic- need to decide today if we want permits for next year
- Can always change things next year if it doesn't work
- Parking Lot- Tournament Committee will meet again between Oct & Jan to work on more details and wordsmith bylaws

# Goals of the Tournament Committee Proposal

- Leverage TBF changes to increase membership, more non-boaters, More members= more sponsors
- Leverage TBF high school success- Get high schoolers (& dads)/ college coming to WBF
- Maximize the number of members we can send to divisionals
- Add Flexibility- try to make everyone happy
- Reduce costs to Federation and Anglers

## Proposed Changes

- Eliminate current zone and state process as is
- Change to 3 One-Day Divisional Qualifiers spread around the state
- Anyone can fish any or as many Divisional Qualifiers as they want
- Divisional Qualifiers will be a Boater- Co-Angler format
- Must sign up as a boater co-angler pair- can be members from any club, but fish separately
- Entry Fees- \$200 \$100 75% payout at ramp

## 3 Divisional Qualifiers

- 2 Ways to go on- Flexibility
  - Each Individual Div Qualifier will take top 7% of Boaters and top 7% of CoAnglers to Divisionals (for those who like our current process)
  - Remainder of slots (3%) come from cumulative points from all 3 Div Qualifiers, best 2 of 3. (for those who want to have a trail format)
- State Angler of the Year- top cumulative points winner
- Round % down, always equal Boater- CoAngler
- If person qualifies both ways- individual takes priority, alternate goes down to next cumulative

### Mr. Bass a Divisional Qualifier too

- Mr Bass becomes a 4<sup>th</sup> Divisional Qualifier
- Change Mr Bass and Observer to Boater-CoAngler format
- Top Mr Bass Boater and Mr Bass CoAngler from each club eligible to fish- each club decides how to select them
- \$200 \$100 entry fee, 75% payout at ramp
- Top 10% of Boaters and top 10% of co-anglers go on to Divisionals

# Additional Changes

- Have at least 1 Div Qualifier in conjunction w/ youth/ HS tournament (One Sat- One Sun)
- Criteria for club to send 2 man per club- Reps meetings, Youth or Conservation project, in good standing meeting with all Federation requirements
- Eliminate Zone Director Positions- replace with appointed tournament committee members specific to each tournament location
- Rescind rule requiring to be member the prior year and also rescind 1<sup>st</sup> year free

# Samples Numbers

- 30 clubs- 30 boaters & 30 co anglers
- Mr Bass- 3 boaters & 3 co anglers
- 3 Divisional Qualifiers- 100 boats each
  - -7 boaters & 7 co anglers each
- Cumulative Points- 9 boaters & 9 coanglers

Total= 63 Boaters & 63 CoAnglers to Divisional
 2 Boaters and 2 CoAnglers to Nationals

# Parking Lot- Topics for next Tournament Committee Meeting

- Continue incentive for top 10 or 12 of cumulative points? Sponsor discounts, shirts, pay entry fees? Raffle Money
- VP/ tournament director to last spot to Divisionals? Cannot fish in tournaments.
- Define points system
- Requirement to fish 6 club tournaments? Let clubs decide.

# Parking Lot Continued

- What if someone qualifies as both a boater in one and a coangler in another? Points would stay separated.
- Method to hook up boaters who need a nonboater?
- Changes in pre-fishing limits?
